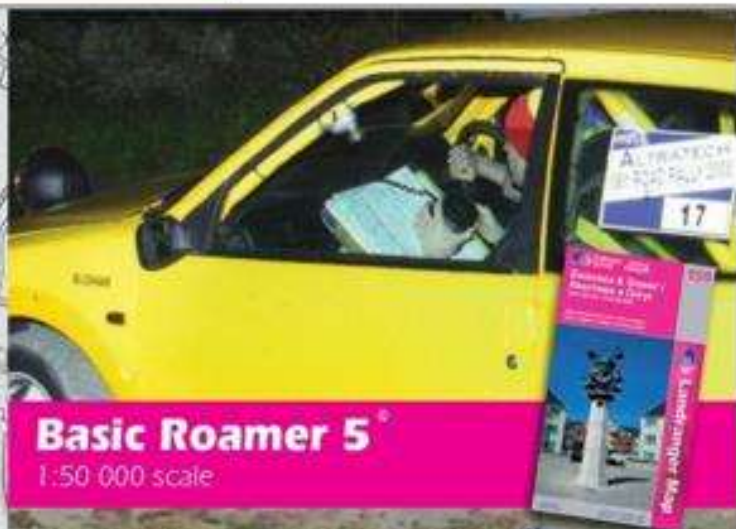
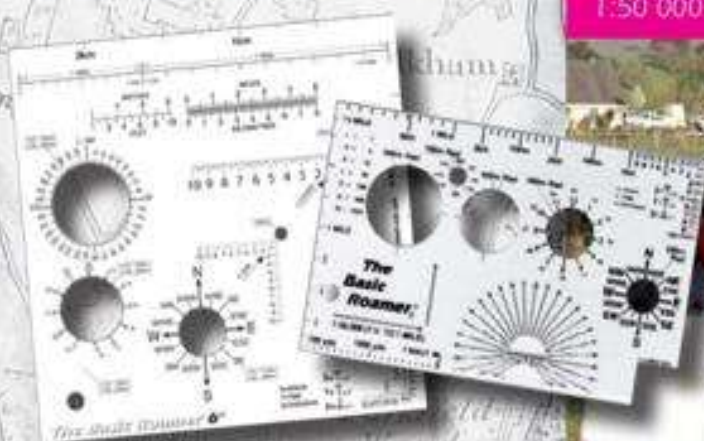

SUPPLEMENTARY REGULATIONS

1. ANNOUNCEMENT

Carmarthen Motor Club Ltd. will promote an Interclub Permit Road Rally on the 23rd/24th of September 2023 to be called The Autumn Road Rally. All competitors will require an RS Interclub Motorsport UK competition licence to participate in this event.

The event is a qualifying round of the 2023 WAMC Road Rally Championship, supported by The Basic Roamer Company <http://www.thebasicroamer.co.uk/>

2. JURISDICTION

This meeting will be governed by the General Regulations of Motorsport UK (Incorporating the provisions of the International Sporting Code of the F.I.A.) these Supplementary Regulations and any written instructions that the organising club may issue for the event.

3. AUTHORISATION

4. ELIGIBILITY

The event is open to all fully elected members of Carmarthen Motor Club Ltd. and members of clubs affiliated to the Welsh Association of Motor Clubs.

All competitors must produce a valid Motorsport UK Competition Licence and club membership card as appropriate for inspection at Signing On.

Competitors **WILL NOT** be able to apply for an RS Interclub Licence at signing on. Licences can be applied for online on the Motorsport UK website.

Competitors who have already applied for a licence, but are unable to produce it at documentation, **WILL HAVE** to pay a non-refundable fine to the MOTORSPORT UK of **£37.00**, as per **H.21.1.2** (Part 3 - Appendix 1 - Section 1)

Motorsport UK has a 15-day turnaround target for processing licences, not including weekends or bank holidays

5. PROGRAMME OF THE MEETING

The event will start and finish from the Carmarthen Cattle Market, Llanllwch, Carmarthen. The total mileage will be approximately 100 miles on metalled and un-metalled public roads and tracks, using **maps 145, 146, 158 & 159** (1:50,000 OS Landranger Series) latest editions. The event will contain competitive sections on the public highways timed to an accuracy of less than one minute. These sections will be run in accordance with the requirements of the Motorsport UK Ltd.

Noise Test and Scrutineering will take place between **16.00 - 20.30**. Any crew NOT signed on by **21.00** **WILL BE DISQUALIFIED** and their place offered to a reserve entry. This ruling **WILL BE STRICTLY ENFORCED**. Details of locations will be published in the final instructions.

Cars will be identified by 2 rally plates supplied by the organisers which must be affixed to the rear nearside and the rear of the car as per **R6.1.1**. These must be removed upon completion of the event or on retirement - it is the competitor's responsibility to ensure that the plates are legible throughout the event.

Competitors should ensure that they carry enough fuel to travel approximately 65 miles. Entrants will be supplied with a Rally Pack at Signing-On upon production of a completed process card.

NOTE: DUE TO SPECTATOR RELATED PR PROBLEMS, ANY COMPETITOR FOUND TO BE DIVULGING ROUTE INFORMATION TO NON-COMPETITORS MAY BE DISQUALIFIED.

ANY COMPETITOR FOUND 'PRACTISING' ON THE LISTED MAPS FOLLOWING THE PUBLICATION OF THESE REGULATIONS, MAY ALSO BE EXCLUDED. HOUSEHOLDERS ON ROUTE HAVE BEEN ASKED TO NOTE DOWN THE NUMBER PLATES OF ANY OFFENDING VEHICLES AND TO INFORM

THE ORGANISERS.

All the Organisers times and mileage shall be deemed correct having been established in accordance with **R6.2.4**

All Organiser's road signs (e.g. CAUTION, NO, CARE, OK, ARROWS) are mandatory.

6. CLASSES

The event will consist of four classes, these are as follows.

1. Class 1 - Masters

Either crew member having won a National B / RS Inter Club or higher status road rally in the last 5 years.

2. Class 2 - Experts

Either crew member having finished in the Top 10 of a National B / RS Inter Club or higher status road rally, or a Top 5 of a clubman road rally in the last 5 years.

3. Class 3 - Semi Experts

Any crew not eligible for the other three classes.

4. Class 4 - Novices

Neither crew member having won more than 2 class awards on a road rally.

NOTE

- a) Competitors eligible for 2 or more classes must enter the higher class.
- b) Crews may be re-classified at the discretion of the Organisers.
- c) **Entries accepted without seeding information will run at the rear of the class entered.**
- d) No discussion will be entered regarding seeding. **Penalty - Disqualification**

8. ENTRIES

ALL ENTRIES MUST BE MADE ON AN OFFICIAL ENTRY FORM AVAILABLE VIA THE CARMARTHEN MOTOR CLUB WEBSITE.

The Entry fee is £130. (To include 2 breakfast tickets)

The procedure for the submission of entry forms shall be as follows:

- a) Entries are to be submitted by **e-mail only**. Entry forms may be completed electronically, or filled in manually and scanned in.
- b) **Entry applications open at 19.00 on Monday 14th August 2022**, and are to be sent by email to CmcEntry@aol.com. **Entry applications received before this time will not be considered. Entry fees are not required to be submitted with the initial entry application.**
- c) Entries will be acknowledged electronically as soon as possible, and in any case, within 7 days. The acknowledgement will state either:
 - i. We are in a position to accept your entry
 - ii. You are placed on the reserve list and will be contacted further if it appears that we may be in a position to accept your entry.
 - iii. Your entry cannot be accepted.

- d) If option i applies, payment is to be made via BACS within 48 hours of the acknowledgement email being sent – **payment details will be included on that email**. If a BACS payment is not received within the 48 hours stipulated, the entry may be offered to another competitor. If appropriate, acceptance of the entry will be confirmed upon receipt of the entry fee within the stipulated period.

Any payment made on the night must be in cash. The consequences of failure to adhere to this will lie with the competitor.

The maximum entry for the meeting is 90, plus 15 reserves per class. The minimum is 40. The minimum for each class is 5. Should any of the above minimum figures not be reached the organisers have the right to either cancel the event or amalgamate classes as necessary.

The organisers reserve the right to retain 20 places for allocation at their discretion **H29.1.3(a)**. All other entries will be selected on a first come first served basis.

The organisers shall retain 35 places for registered contenders for the 2023 WAMC Road Rally Championship, until 28 days prior to the event, August 26th, 2023.

Competitors who choose to indicate on the entry form their intention to register for the WAMC Championship, perhaps to try and safeguard their entry, but who then fail to register for the Championship before the start of the event, will be refused a start, and will forfeit their entry fee.

Any entry containing a false or incorrect statement shall be null and void and the entrant deemed to be guilty of a breach of the General Competition Rules of the Motorsport UK. The entry fee may be forfeited in accordance with **D19**. The Organisers may conduct random checks to establish the validity of all or some of the information contained on the entry form.

It is a condition of entry that competitors must provide at least one marshal. Their details must be given on the entry form, and they must also Sign On. **They must man their allocated control for the duration specified on their instruction sheet.** Failure to comply with the above requirements will result in disqualification of that entry crew and no refund of entry fee.

Therefore, please bear in mind, **NO MARSHAL - NO START NO REFUND – NO DISCUSSION** **H29.1.3(e)**.

The entry closes initially for seeding on the 16th of September. Late entries may be accepted at the organiser's discretion up to the 20th of September 2022.

Cancelled entries must be made in writing or via email to the entry secretary following any telephone discussion. No verbal cancellations will be accepted. Refunds may be made at the organisers discretion, dependent on the entry being taken by a reserve, but in any event a £15.00 administration fee may be retained at the organiser's discretion.

The Organisers reserve the right to refuse an entry should they have reasonable grounds to do so.

In the event of an oversubscribed entry, priority will be given to a fully completed entry form.

Final Instructions will be posted on the Carmarthen Motor Club website in the week leading up to the event unless advised otherwise.

10. GCR MODIFICATIONS

All other General Regulations of the Motorsport UK apply as written except for the following which are modified:

D8.1.4 - Any notice displayed at the start or on route bearing the signature of the Secretary of the Meeting or of the Clerk of the Course shall have the same authority as these SR's. It is the competitor's responsibility to note any information displayed at the start.

R9.1.1 – R9.1.2 - Give ways will be used to define the route.

R9.1.3 – R9.1.4 - All competitors will be required to stop at all junctions approached on roads controlled by Give Way and Stop signs and places specified on the Route Card. Several such places will be manned by Judges of Fact.

R12.1 - The event will be timed according to Scheduled Timing.

R12.6 – R12.6.1 - Competitors will be required to reduce lateness at certain locations on route.

R12.2.7 - Maximum Permitted lateness for competitors will be as follows:

Masters: 20 min 59 secs

Experts: 20 min 59 secs

Semi Experts: 30 min 59 secs

Novices: 30 min 59 secs

R12.8.1 – R12.8.3 - Certain Sections of the Route will be timed to an accuracy of less than one minute.

R2.3.3 - Secret checks may be established without prior notice e.g. at Give Ways etc. to ensure compliance with the route.

R15.1 - R15.1.2 - To be classified as a Finisher, a competitor must report to and receive a signature at the following:

- Two thirds of the controls listed in the route card.
- All Main Controls
- Damage Control
- Within their maximum permitted lateness and in the car in which they entered the event.

Assessment of performance will be decided firstly by the number of Fails then by the amount of time lost. Ties will be decided in favour of the furthest cleanest, smallest engine capacity or any means deemed necessary by the Organisers.

Any competitor who, in the Organisers opinion, causes an obstruction of the route which necessitates the cancellation of a section, whether deliberate or unintentional, shall be liable for a penalty at the Organisers discretion. This penalty may be in the form of time or fails added to their overall total, or in aggravated instances, disqualification from the event.

Provisional results will be published at the finish venue as soon as possible after the finish of the event in accordance with **H34.1.1 – H34.1.8**. Competitors will be supplied with one Results Query Form. More than one query on the same matter must be treated as Protests.

Protests must be made in accordance with **C5.1 - C5.7**. They must be in writing and handed to an official of the event and accompanied by the appropriate fee of **£65.00** (Appendix 1 Section 13).

Competitors **must not**, under the penalty of Disqualification, enter the Results Room uninvited.

The Organisers reserve the right to cancel sections from the results if they deem it fairer to do so. "Force Majeure" etc. not with-standing. Time Controls at which, in the Organisers opinion, inaccurate times may have been given to competitors, shall be considered as either Passage or via Controls,

A copy of the final results will be published on the Rallyroots website (rallyroots.com) and the Carmarthen Motor Club website within 7 days of the event.

12. SCRUTINEERING

Scrutineering will be in compliance with the Road Traffic Act General Regulations, Section J and technical regulations **R4.1** and **R18**. Cars will also be required to undergo a Noise Test and if more than 86dba is registered at 2/3rds of maximum rpm at 2m from the centre of the car on the noise meter, they will not be permitted to start **J5.16-18**. Noise checks may also be performed on route. Crews failing either noise test or scrutineering will not be permitted to start and will not have their entry fee refunded.

Close attention will be paid to the following at Scrutineering:

- Spill Kits.
- Body Damage.
- Brakes where hydraulic handbrakes are used, cables must also be fitted.
- Lights must comply with the Road Traffic Act.
- Have no more than 4 forward facing beams (excluding sidelights/indicators) Spotlights must extinguish on dipped headlamp beams and must not exceed a width of 222mm.
- Reversing lights must not exceed 24 watts power and have an internal warning indicator if independently operated.
- Steering Play.
- External marshal/Navigation lights are prohibited.
- Indicators.
- Brake lights.
- Side lights
- Number-plate Lights.
- Flexible fuel lines must be secured with steel clips Washers and Wipers.
- Horn.
- Battery must be secured with earth lead coloured yellow and with the positive terminal insulated.
- Seats must be secure.
- No loose items within the vehicle.
- Throttle linkage must be in good order and to specification.
- A maximum of 2 spare wheels must be securely located.
- A Red reflective Warning Triangle must be carried.
- A First Aid kit must be carried.
- MOT Certificate must be produced.
- Vehicle Registration Document must be produced.
- Bodywork and paintwork must be in good serviceable order.
- Air filters must be fitted.
- No radio transmitting devices are permitted.
- **Exhaust** - All vehicles must comply with exhaust and silencing regulations and must not be fitted with any temporary parts to help meet the required silencing levels as in **J5.18**.
- **Brakes** - Brakes are free but must comply with Construction and Use Regulations. A hydraulic handbrake is permitted. This must incorporate the existing manufacturers' handbrake lever, mounting position, and pivot point, as per **R18.6.3**.

Tyres

- **ONLY** E-marked tyres are permitted.
- Must be legal for use on the public highway at all times during the event.
- Cutting of tyres is not permitted.
- Competitors should familiarise themselves with the following Blue Book regulations.
- **L3.2**. For all Road, Navigation, Targa Road and Historic Road Rallies tyres are free subject to the following;
 - a) Tyres on the current FIA List of Asphalt Eligible Tyres are permitted; including sizes not homologated.
 - b) Tyres on List 1B (from 2020) and List 1C are not permitted other than the Avon CR28, the Avon CR6ZZ and the Pirelli P7 Corsa Classic, for pre 1/10/90 registered cars, the Yokohama A021R (manufactured before 01/11/14), and the Yokohama Advan A052.
 - c) Tyres marked for "competition use" are not permitted with the exception of tyres on List 6 and

3.2a).

- **Please ensure that E-marks are visible for inspection at scrutineering.**

13. CONTROLS

There will be 6 types of controls:

Main Control (MC)
Time Control (TC)
Passage Control (PC)
Route Checks (RC)
Via (via)
Secret Check.

At each Main and Time Control, the marshal will enter the time shown on the control clock and sign the appropriate place on the time card. Whilst at Passage Controls, the marshal will only sign the time card in the appropriate place.

Some controls may not be manned, and these may be represented by a Route Check (Code Board) Competitors must note the letters and/or numbers displayed on these boards in an inked pen to the relevant place on their timecard before proceeding. The code must be endorsed by the marshal at the next manned control (TC, PC). Route checks will be preceded by a "C" or Control board less than 50 yards ahead of the board.

Controls must be visited in the order specified in the route card, any control visited out of order will be deemed not to have been visited, visited twice and/or visited in the wrong direction. (Competitors will be penalised accordingly).

At all manned controls excluding from Secret Checks a "C" or "Control" board will be approximately 50 yards ahead of the control on the left side of the road. At Secret Checks the control board will be at the manned control.

Sections of the route may include not on map triangles that will have a control area of 3 metres or less. They will be identified in the route card and a detailed diagram given to all competitors; they will be preceded by a control board on the correct direction approach. (Control board will be less than 50 yards ahead of manned control).

Should any entry on the time card not be legible or not appear authentic, it may be deemed not to have been made. Organisers may refer to marshals check sheet in case of doubt.

It is not the duty of any marshal to interpret regulations or other written instructions to a competitor or to explain the meaning and/or effect thereof.

It is the responsibility of competitors to read and understand these regulations and all written instructions.

Controls will open 30 minutes before the due time of the first car and close 45 minutes and 59 seconds after the last car is due.

Competitors must be aware that WAMC Common Regulations 2023 will apply to this event and competitors must remind themselves of point 15.2.1.2. **Competitors must: Dip lights and extinguish auxiliary lights at the 50m board. Reduce speed so that they can stop at the Marshal's location without locking the wheels. Leave the Marshal's location ONLY when the Marshal is clear of the car.**

Judges of Fact may be present at controls to observe the above. Failure to comply with the above will result in Disqualification.

Any competitor who causes any form of harassment to a marshal or any other official, or who remains in a control area subsequent to an instruction to depart, will be reported to the Stewards of the meeting. The organisers reserve the right to disqualify any such competitor.

An altered, amended, or countersigned Time Card will be accepted only if it was countersigned by the marshal at the time of alteration. **IT IS THE COMPETITOR'S RESPONSIBILITY TO ENSURE THAT THEIR TIME CARD IS CORRECTLY MARKED – COMPETITORS WILL BE DISQUALIFIED FOR DEFACING OR ALTERING A TIME CARD.**

14. **FORMAT**

The event will use scheduled timing methods **R12.2.1**. Timing will be by satellite linked digital clock set at BBC time **R12.8**.

STANDARD SECTION

This is a section where a time penalty will be applied for being early or late. (See section 11 of these Supplementary Regulations). Timing at the controls will be when the time card is presented to the marshal and NOT the time of entering the control area **R12.3**. Time controls situated at start, finish or intermediate time controls on Standard section are shown as (TC)

NEUTRAL SECTION

These are deemed **QUIET** sections and are used to take the rally through PR sensitive or densely populated areas. They are timed at a low average speed and competitors must complete the section in as high gear as possible and without the use of auxiliary lights (except as permitted by law when driving in fog). Any competitor deemed by a judge of fact, to be making excessive noise or using auxiliary lights will be disqualified.

NO penalty will be incurred for lateness other than for exceeding maximum lateness. Any lateness incurred in the section will be cumulative towards maximum lateness.

Competitors will be instructed to reduce lateness en route. Competitors who wish, may miss a control or controls. They will be penalised in accordance with **R13** for every control missed.

Competitors late at one control may be the equivalent amount late at succeeding controls without further penalty provided maximum lateness is not exceeded.

Where a control at the end of a section timed to the second also forms the start of a section timed to the minute the departure will be taken as the time of arrival but to the preceding whole minute, this will be in accordance with **R12.5**.

Timing will be when the time card is handed to the marshal.

QUIET ZONES

These areas are PR sensitive, and competitors must extinguish auxiliary lights, dip headlights, and drive in the highest possible gear. Driving standards observers (D.S.O's) may be present in these areas.

JUDGES OF FACT AND DRIVING STANDARDS OBSERVERS (D.S.O's)

Judges of Fact or D.S.O.'s will be appointed to adjudicate on appropriate facts as listed under **R8.1** and **R8.3** including all sub points contained within above listed sections.

For Example:

- Failure to stop at give ways as specified in the route instructions (GW),
Note. All wheels must be seen to stop, and all forward motion must cease.
- Excessive noise, speed, and light.
- Driving in a manner likely to bring the sport into disrepute.
- Compliance with special restrictions e.g. Quiet Zones, Black Spots etc.
- Not completing a test as per diagram.
- Failing to extinguish auxiliary lights on Neutral Sections.
- Failing to Extinguish Auxiliary Lights on entering a control. WAMC Common Regulation: **15.2.1.2**
- **Competitors should note that failure to comply with required regulation listed and/or stop when requested by a Judge of Fact or DSO is penalised by DISQUALIFICATION.**

A Judge of Fact / DSO board en-route may indicate the presence of such an official and competitors must stop at this point.

A full list of Judge of Facts and DSO's will be displayed at signing on.

The route has been plotted using a Basic Roamer V5.

Competitors are only allowed to recover time at (MC2, MC3) located after Petrol.
The official notice board will be displayed at Signing on.

15. RALLYGUARD INSURANCE

The Organisers have applied to Marsh Sport for a Blanket Cover Note under the above scheme. This will provide competitors who need to use the scheme with the Third Party Cover necessary to meet RTA requirements on the Road Sections of the event.

All applicants wishing to use the scheme must be able to comply with all points of the Marsh Sport Motorsport Declaration: -

- I do not have the Third Party Road Section extension on my current Motor Insurance.
- I am aged 19 or over.
- I have had no more than 1 fault claim in the last three years
- I have no more than a maximum of 6 conviction points or a licence ban on my UK driving licence
- I have the appropriate competition/club membership licence as well as a UK/EU driving license and if my license is provisional I will be supervised by an adult over 25.
- I have no physical or mental disabilities
- My vehicle is MOT'd, Taxed and Insured for the road
- I have no other material facts to disclose
- Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

If you comply with all points above, please simply return your completed Driver Declaration Form to the event secretary, accordingly. If you are unable to comply with any of the above points we will require your completed Driver Declaration Form, which should be returned to us by the event secretary, prior to the event, to allow sufficient time for a Letter of Acceptance to be issued.

The basic rate for the additional cover of the event, before any loadings, will be £29.00.

16. DAMAGE

All competitors must complete a damage declaration form which must be handed in at the damage control which will be situated on the entrance of the finish car park. In the case of retirement, the form must be sent to the secretary of the meeting within 48 hours. Failure to comply will be penalised as **R15.1.2**

17. PACENOTES

The use of pace notes or map marking is forbidden. Navigation on the event must be carried out using OS Landranger maps (1:50,000 scale) 145, 146 and 159 ONLY. Any other form of navigation will be classed as pace notes.

A pace note will be defined as any markings not complying with **R9.1.6** other than those provided by the organiser. Any competitor found in possession of such map marking/pace notes will be disqualified. There will be an initial map check at signing on, and thereafter random checks will be conducted throughout the course of the event.

IN THE INTEREST OF SAFETY, MOBILE PHONES MAY BE CARRIED IN COMPETING CARS BUT MUST BE SWITCHED OFF BETWEEN MC0 AND MC4. FAILURE TO COMPLY WITH THIS RULING WILL RESULT IN DISQUALIFICATION.

18. SERVICE

Service will not be permitted at any time during the duration of the event, except by the crew working on their own car. This also applies to the halfway halt. The penalty for infringement will be disqualification. However, competitors may work unaided and borrow any tools from the proprietor of the halfway halt or from fellow competitors in the event only.

19. PHOTOGRAPHS
